3. Licensee understands that the use of the premises shall be confined to the facilities requested in this agreement.

5. Licensee agrees to remove all personal property immediately after the party (dishes, food, clothing, bottles etc.) and to collect and deposit trash in receptacles provided for that purpose.

7. Licensee agrees that in the case of cancellation of the event, \$100 of the deposit is non-refundable. A full refund (minus \$100) will be given if event is cancelled 14 or more days before agreed upon event date. Any cancellation within 14 days of the event is not refundable.
8. Management has the right to cancel reservations or refuse the use of the club for any reason.
